Application Exemption Article 71.1 Basic Regulation

This form **can be used** to apply for an exemption based on Article 71.1 of the Basic Regulation (EU)2018/1139. The Civil Aviation Authority – The Netherlands may grant an exemption from the substantive requirements laid down in the Basic Regulation and its implementing rules in the event of in the event of urgent unforeseeable circumstances or urgent operational need provided certain conditions are met. An exemption article 71.1 Basic Regulation may only be granted to natural or legal persons residing in the Netherlands.

This form **cannot be used** to apply for a an alternative means of compliance.

The "Regeling tarieven luchtvaart 2008" (national regulation for aviation fees) applies. An invoice will be send upon receipt of the application to the billing e-mail address. The exemption may be issued prior to receipt of the payment if the urgency warrants such situation. An application which is not complete will not be investigated. An application is only complete if all necessary documents and the payment of the fee are received.

An exemption MAY be issued; it does not mean that an exemption MUST be issued.

The investigation of an application can take up to maximum of 8 weeks, be sure to apply on time. In case of urgent situations (i.e., within one week), the time needed for the investigation will be upon agreement of the applicant and ILT.'
